## 1. Policy Purpose

This policy establishes a structured, lifecycle-based membership framework for the Compliance Institute, Nigeria, to promote sustainability, early engagement, professional progression, and governance clarity.

## 2. Scope

This policy applies to all current and prospective members of the Institute.

## 3. Membership Categories

CIN membership shall consist of the following categories:

1. Subscriber
2. Student Member
3. Designate Compliance Professional (DCP)
4. Associate of the Compliance Institute, Nigeria (ACIN)
5. Fellow of the Compliance Institute, Nigeria (FCIN)
6. Honorary Fellow (by distinction)

## 4. Student Membership

**Status:** Non-certified, non-voting

**Eligibility:**

- Students of recognized tertiary institutions
- Degree or HND holders
- Early-career or transitioning professionals

**Fees:**

- Registration: ₦5,000 (one-off)
- Annual dues: ₦10,000

**Rights & Benefits:**

- Access to approved member resources and events
- Discounted participation in Institute programmes
- Career development and mentorship opportunities
- No voting or governance rights

## 5. Certified Membership Annual Dues

- DCP: ₦12,500
- ACIN: ₦20,000
- FCIN: ₦25,000

Only **ACIN and FCIN** members in good standing shall exercise voting rights.

## 6. Implementation & Effective Date

This policy takes effect on 1 January 2026.

## 7. Review

The policy shall be reviewed periodically by EXCO in line with institutional strategy and financial sustainability objectives.
